Terms & Conditions (Demonstration)

1. Parties

This FICTIONAL demonstration agreement is entered into by Texas Regional Hospital ("TRH"), a fictional 50-bed rural Texas PPS hospital used solely for product demonstration, and Blue Cross and Blue Shield of Texas (the "Counterparty"), referenced here only as a representative example of the payer participation agreement category. No real relationship, endorsement, or contract exists or is implied.

2. Scope of Services

The Counterparty will provide services consistent with a payer participation agreement for the benefit of TRH. Specific scope, service lines, and deliverables are enumerated in the Exhibits, which are fabricated for demonstration and contain no protected health information (PHI).

3. Fees & Pricing

Consideration under this demonstration agreement is \$18,900,000 / year expected net revenue. Pricing bases, tiers, rebates, and escalators are illustrative only and appear in Exhibit A / Exhibit B where referenced by the Harsight VERIFY extracted-terms pane.

4. Invoicing & Payment

Invoices are issued per the cadence in the Exhibits. TRH may withhold or recover amounts for duplicate lines, over-rate lines, off-contract spend, missed credits, or price-tier misses identified through VERIFY exception review. All example invoices are fictional.

5. Service Levels

The Counterparty shall meet the service levels stated in Exhibit A, including uptime, fill rate, turnaround, or audit thresholds as applicable to the category. Service credits apply when a service level is missed. All SLA figures are manufactured for the demo.

Terms & Conditions (Demonstration)

6. Obligations & Reviews

The parties shall conduct periodic business reviews. The Counterparty shall maintain the documentation, accreditations, and compliance artifacts listed in the Exhibits. VERIFY tracks each obligation against its clause reference.

7. Compliance & Documentation

The Counterparty shall maintain current insurance, applicable licensure/accreditation, and, where relevant, a Business Associate Agreement. This demonstration document intentionally contains no PHI and no real personal contact information.

8. Term & Renewal

Term: Evergreen — annual review (renewal 2027-03-31). Renewal and notice mechanics are stated in the term section and surfaced by VERIFY. Notice windows in the demo drive the renewal-timing and priority-action logic.

9. Governing Nature (Demo Notice)

THIS IS A FICTIONAL DEMONSTRATION DOCUMENT. It is not a real agreement, creates no obligations, and must not be relied upon. It exists only to demonstrate the Harsight VERIFY contract-intelligence workflow for the fictional Texas Regional Hospital.
